BGAS examination requirements of BGAS/ER1-Issue 5 are attached herewith for your ready reference and usage. You are requested to fill up the enrolment form and send it along with DD/Wire Transfer, Vision Certificate and 2 nos. PP size photographs with name and signature affixed on the back side.

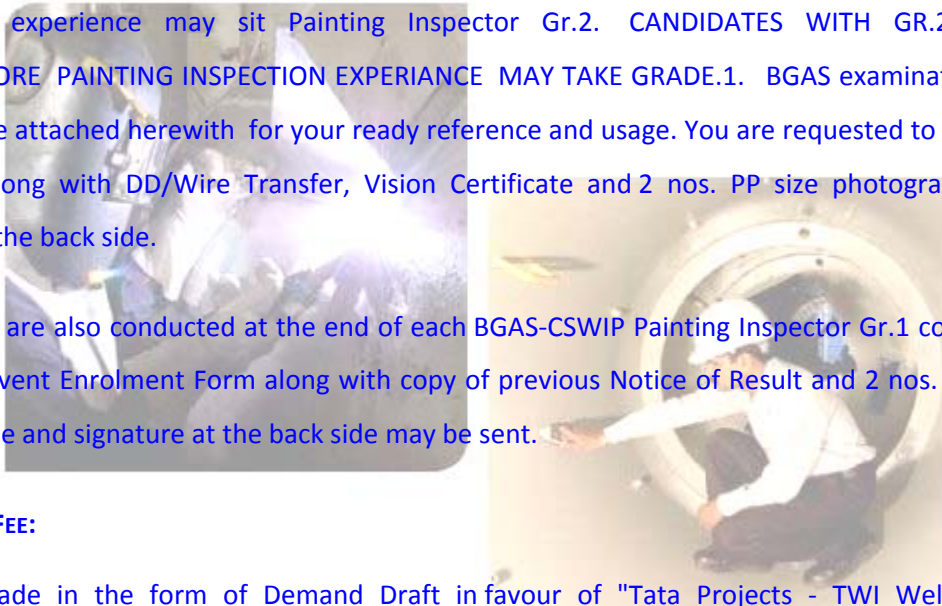
